SWIMMING POOL PERMIT

All contractors are required to have a current business license from a Georgia municipality

The pool coping, decking, or any attached part thereof shall be located no closer than 5 feet from any property line. The pool shall be enclosed with a code approved fence or barrier, a minimum of 5 feet high, copy of which can be obtained from the Department. The required pool barrier, including gates, alarms and covers (if necessary) must be installed prior to filling the pool with water.

Contact Public Works (770) 974-5233 to apply for a land disturbance permit. Development cannot issue a permit without an approved LDAP. All plumbing, gas and electrical and building work must be permitted separately and are not part of this permit.

Inspections must be approved on all building, plumbing and electrical work, including the required common equip-potential bonding grid and all its associated parts, prior to such work being covered by concrete, grout or fill material. Please call for an inspection prior to the placement of grout or concrete even when steel reinforcing bars are not used.

A final inspection is required after all the work is completed; the pool is filled with water and the pool barrier, and its associated parts have been installed.
